Director's Note

During the first three months of the academic year, from April to June 2018, the former Director of the CSSSC, Prof. Tapati Guha Thakurta, continued in her post while the process of selection was underway for a new director. The Board of Governors made its selection, following due process, in the month of June, and I assumed charge as Director on 11 July 2018. I would therefore like to start by thanking my predecessor sincerely for the hard work and genuine effort she has put into her time as Director of the institute, overseeing long-overdue faculty recruitments – for both general and reserved categories – apart from administrative recruitments of important posts such as the Registrar and Librarian, and the setting up of the beautifully renovated Jadunath Bhavan Museum and Resource Centre, which is now flourishing as a location for seminars and book events in the heart of the city. As well as these, she has also dealt with the daily and yearly routine requirements of overseeing the functioning of the CSSSC as a whole with dedication and sincerity, and we are grateful for her efforts.

The last academic year has seen three new members of faculty at the Centre, and we welcome Dr. Karthick Ram Manoharan as Assistant Professor in Political Science, Dr. C. Satish as Assistant Professor in Sociology and Dr. Asha Singh as Assistant Professor in Gender Studies, all of them joining in their posts after April 2017. The Centre has now introduced and formally adopted the Career Advancement Scheme, which has currently been implemented for its faculty. The first set of applications was invited in July-August 2017, and Associate Professor Saibal Kar (Economics) was the first to be appointed Professor in Economics under the CAS regulations. The two senior ICSSR fellows who had been working at the Centre, Prof. Ramprasad Sengupta (Economics) and Prof. Kalyan Mandal (Sociology) completed their terms in the first quarter of 2018 and spent much of the past year completing their respective projects as per the norms of their fellowship. Prof. Partha Chatterjee and Prof. Gautam Bhadra continued as Honorary Fellows, working actively with the Centre's faculty in teaching, editorial work, and guidance of students who approached them for help, giving freely of their time and expertise – we are grateful for their continued presence amongst us. On the last day of the academic year, 31 March 2018, two of our senior-most faculty - Prof. Manas Ray and Prof.

Lakshmi Subramanian – retired from their positions. We have benefited from their institutional presence and dynamism for many years and we thank them for their exertions on our behalf over the years, teaching and supervising, running workshops, organising conferences and exhibitions and running projects, apart from their own research work conducted in this time resulting in publications that add merit to the Centre's profile.

The Centre has been implementing the appointment of new faculty under the Reservation Roster in a phased manner under the directives of the ICSSR. Following the first round of appointments, a second round was initiated to fill remaining posts lying vacant in this category. Two posts for Assistant Professor, one for Associate Professor and two for Professor were advertised in December 2017. Following a Screening Committee meeting on 14 February 2018, a Selection Committee was set up in order to hold job talks between 16 -18 April 2018. The outcome of this process will be reported in the next Annual Report.

During the year, among the internal professors, Prof. Sugata Marjit and Lakshmi Subramanian retired from the Board of Governors and were replaced by Prof. Manabi Majumdar and Jyotsna Jalan. Among the external members, the West Bengal government representative, Prof. Gopalchandra Misra and Prof. Sankar Kumar Ghosh, VC, Kalyani University, have retired, being replaced by Prof. Subha Sankar Sarkar as the West Bengal government representative, and Prof. Somnath Ghosh, VC, North Bengal University.

The M.Phil and Ph.D programmes of the Centre continue to flourish, receiving a good number of applicants every year. In the M.Phil in Social Sciences (year 2015-17), 11 students (out of 18) submitted their dissertations in May 2017 and all were awarded the M.Phil degree in December 2017. 22 students (year 2016-18) completed their course work and cleared the Qualifying Examination. The students then commenced their research work and made two presentations during this period. For the current M.Phil (2017-19 year), 18 students were admitted out of a total of 276 applicants and 2 students dropped out over the course of the year, leaving a batch of 16 students. The Centre currently has 74 students enrolled in its Ph.D Programme of whom 8 are receiving ICSSR Fellowships, 4 receiving Junior Research Fellowships and 2 receiving Senior Research Fellowships from the UGC. During the last academic year 10 scholars took admission into the Programme.

The CTRPFP and the JBMRC continued to flourish, hosting speakers, workshops and programmes throughout the year. The latter has come to the last phase of the Ministry of Culture grant that has sustained it so far and urgently needs to build a corpus to sustain itself in the future. Regarding the Annual Lectures of the CSSSC, the Deuskar Lecture could not be held in 2017-18; however, the R.C. Dutt Lecture was delivered by Professor Esther Duflo, Co-Founder and Director of the Abdul Latif Jameel Poverty Action Lab (J-PAL) and Professor of Poverty Alleviation and Development Economics at the Massachusetts Institute of Technology, on 22 and 23 February 2018.

The Centre has faced several financial difficulties during 2017-18, arising out of procedural delays in releasing grants by the ICSSR, due to which salaries could not be credited into accounts on time in February 2018. The deficit amount accumulated over the last five years due from the West Bengal Government is now standing at 4.45 crore; this year's deficit alone amounted to a sum of 66 lakh. We have made several representations to the WB Government to release at least the dues for arrears to retired faculty and widows as well as current faculty, but the matter is yet to be resolved. On the other hand, we are grateful to the ICSSR for having released a sum of money for the outer repair of the crumbling CSSSC building; nevertheless, the sum being insufficient to undertake the work, we shall be resubmitting a fresh application for an additional sum so that the building may be repaired. A previous grant from ICSSR for the renovation of to a resolution of some of its financial issues and the cooperation and help of its funding bodies in the coming year.

Research Projects At The CSSSC (Funded By External Agencies)

The CSSSC has undertaken several academic research projects. Some of these are intended to augment the holdings in its archives and to organize academic events around these holdings and promote research. It also undertakes surveybased projects and training workshops with a view to developing research capacities. The inter-disciplinary character of the Centre and its faculty has meant that its intervention has been recognized as crucial in developing resources and facilitating research.

Research Projects (Completed)

- 1. Under Asian Development Bank funding: Globalization and the environment in India. Co-coordinators were Sugata Marjit and Eden Yu.
- 2. Under RBI endowment:
 - Inflating Profits and Industry Competitiveness. Co-coordinators were Hamid Beladi, Sugata Marjit and Reza Oladi.
 - International Capital Flow and Wage Inequality with Land Conversion in Poor Countries. Co-coordinators were Sugata Marjit and Saibal Kar.
 - Virtual trade between separated time zones and growth. Cocoordinators were Sugata Marjit and Biswajit Mandal.
- 3. "Shantipur and its neighbourhood: Text and images of early modern Bengal in public and private collections" funded by Endangered Archives Programme of the British Library (United Kingdom). Rajarshi Ghose and Abhijit Bhattacharya were co-investigators of the project.

Protection Fund, Calcutta Stock Exchange. The study has been completed and the final report submitted to the funding agency. Pranab K. Das was coordinator of this project.

Research Projects (Ongoing)

1. The sixth round of award have been received from Endangered Archives Programme EAP921, titled 'Early-modern texts and modern legacies: Digitisation of Manuscripts, Books, Newspapers in southern West Bengal' and planned to focus on diverse nature of manuscripts and books from the districts of Medinipur (east and west), Hooghly and Howrah. Our team just started working for the project and the first major task was, documentation of complete run of Nihar a vernacular newspaper with focus on coastal Medinipur and important for its nationalist undertone being published from Kanthi, East Medinipur. Our team has almost completed working on the run of newspaper that went beyond public knowledge long ago. Apart from this the project is expected to digitize and catalogue four institutional and two individual collections.

The project team has already copied complete set of Nihar from Contai, manuscripts from the private collection of Dr. Shyamal Bera, some important Buddhist tracts from the Bauddha Dharmankur Sabha before moving to the Sadharan Brahmo Samaj, Kolkata. The project is expected to be completed by end of 2018.

Abhijit Bhattacharya is the Principal Investigator of the project along with Dr. Rajarshi Ghose and Ms. Jayeeta Majumder.

- 4. A pilot project on "Media, Aesthetics, Commodities and Publicities in Nehruvian India" under the Indo-German collaboration (ICAS-MP) project. The period of research is from the 1940s to the 1960s. With the help of two Research Assistants, the survey is conducted and documentation work is in progress in two cities, Bombay and Calcutta, over a period of 4 months, March – June 2018, at the end of which, a one-day workshop is planned to be organized with presentations and discussions. It has been planned that this project will be carried over from the pre-phase into the main phase of ICAS-MP activities that will begin in August 2018 and continue into 2019. If arrangements of funding could be finalized with the Godrej Archives and the Tata Trust in Mumbai, the long-term aim of this ICAS-MP project under its History and Media modules is to convene a conference and mount out of this project an exhibition at JBMRC on the new worlds of advertising, products, and publicities of Bombay and Calcutta of the 1940s – 1960s– sometime towards the end of 2019. Tapati Guha-Thakurta is coordinating this project along with Ravi Vasudevan of CSDS.
- 5. During this academic year, time has been spent in getting started with the project on early childhood development and pre-school education, in West Bengal and Karnataka, funded by the ICSSR, New Delhi. Manabi Majumdar is collaborating on this research project with Dr. Rahul Mukhopadhyay of Azim Premji University.
- 6. "Early-modern texts and modern legacies: Digitization of Manuscripts, Books, Newspapers in southern West Bengal" funded by Endangered Archives Programme of the British Library (United Kingdom). Rajarshi Ghose and abhijit Bhattacharya are co-investoigators of the project.
- 7. District Human Development Report, Howrah: This project is funded by the Planning Board, Govt of West Bengal. The data collection, analysis and report writing parts of the project have been completed. Second draft of the report has been submitted to funding agency. The final version of the report would be ready upon receiving feedback from the funding agency. Saibal Kar and Tushar Kanti Nandi are co-coordinators of this project.

- 8. Informality and tax policy: This project is funded by DFID. The objective of the project is to examine the effect of policy to reduce compliance cost on formality decision of small firms. Initial phase of the project involves collecting data on firm that became tax-formal after the introduction of the policy. Data for this phase have been collected in collaboration with the office of Commissioner of Commercial Taxes, West Bengal. Second phase would involve survey based data collection. Tushar Kanti Nandi is coordinator of this project.
- Socio-economic and Health Analysis in Andaman and Nicobar Islands. Funded by ISRO, India, 2018. Pranab K. Das and Saibal Kar are co-investigators of this project.
- 10. MoU with Women's Christian College, Kolkata has been signed for holding seminars and conferences jointly and also apply for research projects from time to time. The students will have access to resources of CSSSC as and when needed. The said college also organized a panel discussion where Prof. Saibal Kar and Dr. Rajarshi Ghose spoke on issues of citizenship in India.

Much of the vitality of the Centre's academic life is supported and sustained by the research of its faculty members. This has been a distinguishing feature of the Centre's academic life since its inception and has been instrumental in its exceptional inputs to the various disciplines it represents. The Centre runs a regular faculty series seminar and reading group that encourages lively and periodic intellectual exchanges among faculty members. It encourages faculty members to collaborate with other institutions in India and overseas to organize joint seminars and workshops. It allows faculty to share their research interests and expertise and undertake teaching and supervision in other institutions in India and overseas. Additionally, the faculty assumes important administrative responsibilities in connection with academic programmes and research activities in the Centre.

On-going Research

- R&D incentives under incomplete information and uncertainty about success: R&D activities always involve uncertainty about the prospects of success. In oligopolistic industries, firms quite often perform R&D to gain an edge over their rivals. The probability of success of R&D depends to a large extent on factors endogenous to firms. Therefore, it is quite likely that the probability of success is known only to the firm undertaking the R&D activity. The rival firms may not completely know probability. This paper makes an attempt to analyze a situation in a duopoly market, where the probability of success of R&D is private information to each firm and each rival firm knows this probability probabilistically. Thus the probability of success of each firm constitutes its type. In this incomplete information framework, information level may vary regarding R&D decision and R&D status. Our results indicate a non-monotonic relationship between R&D incentives and the level of available information.

- Spillover and R&D Incentive under Incomplete Information: Spillovers of R&D outcome affect the R&D decision of a firm. The present paper discusses the R&D incentives of a firm when the extent of R&D spillover is private information to each firm. We construct a two stage game involving two firms when the firms first decide simultaneously whether to invest in R&D or not, then they compete in quantity. Assuming general distribution function of firm types we compare R&D incentives of firms under alternative scenarios

based on different informational structures. The paper shows that while R&D spillovers reduce R&D incentives under complete information unambiguously, however, it can be larger under incomplete information.

- Patent Protection and R&D Incentives under Incomplete Information: When tournament effect is negative, under complete information, whether patent protection increases the incentive for R&D is ambiguous. It depends on the extent of spillover of the new technology. In particular if that amount is less than a threshold value then patent protection increases the incentive for R&D, otherwise it does not. This paper shows that under incomplete information (where the spillover parameter is private information), there are situations where patent protection unambiguously increases incentive for R&D, even if tournament effect is negative, if the distribution function of the spillover parameter is sufficiently skewed and the cost of doing research is sufficiently high.

beyond the human has been operative in many ways in recent humanities and social sciences. Two of the most important strands, each of which affects the other in constitutive ways, come respectively from 'science studies' and from 'theory' in a general sense. This paper tries to trace the differences in the dynamic of thinking associated with these two vantage points. It closely reads two essays, one by Donna Haraway and the other by Jacques Derrida, to bring out the differences in the dynamic of the two positions. In the process, it also alludes to the large body of literature in science studies produced in the wake of Haraway's intervention.

- "The Science Question in Poststructuralism: Ethics and Politics of the Real". The paper deals with the paradox in the pursuit of science that tries to bring together a form of empiricism with reason. It tries to analyze a fundamental opposition between the inductive mode of reasoning active in empiricism and the irrefutable logic of deductions of Reason. In doing this, the paper has to address the question of how faith and (scientific) knowledge remain intertwined. Questions of the originary technicity of being human and its relations to the generality of the structure of writing and the trace-structure have to be addressed in the process.

- "Unhinging the State and the Nation: (Im)Possibilities". There has been recently a call for a disjuncture of the hyphen to think the nation and the state separately. In this call, there is a clear preference for the latter, that is, state. For Judith Butler, the need is to think of an access to the state without the call for an access to homogeneous nationhood. For Gayatri Chakravorty Spivak, a possible search would be for a reinvention of the state as an abstract structure of redistribution, welfare and constitutionality with a persistent effort to keep away nationalisms and fascisms. I try to make a sense of these counter-intuitive moves with reference to certain other coordinates of theorizing on the matter.

Under the Indo-German collaboration (ICAS-MP) project, Jointly conducting (along with Ravi Vasudevan of CSDS) a pilot project on "Media, Aesthetics, Commodities and Publicities in Nehruvian India", taking the period from the 1940s to the 1960s. With the help of two Research Assistants, we are conducting this survey and documentation in two cities, Bombay and Calcutta, over a period of 4 months, March – June 2018, at the end of which we will have a one-day workshop with presentations and discussions. We are hopeful that this project will be carried over from the pre-phase into the main phase of ICAS-MP activities that will begin in August 2018 and continue into 2019. If we can come to arrangement of funding with the Godrej Archives and the Tata Trust in Mumbai, the long-term aim of this ICAS-MP project under its History and Media modules is to convene a conference and mount out of this project an exhibition at JBMRC on the new worlds of advertising, products, and publicities of Bombay and Calcutta of the 1940s – 1960s– sometime towards the end of 2019.

The interest lies in moving from the different histories of private and institutional collecting that made for the far-flung dispersal and relocation of objects, to thinking about the portability, mobility and transactability of objects in the material cultures of the past and the present.

- The new visual field of populist politics: a case study of Mamata Banerjee's Kolkata

Taking off from the point where the book on Durga Pujas of contemporary Kolkata, have been considering not just the new overtly political life of the festival in the city, but also a set of new equations that have been forged between the goddess, her mega festival and the TMC in its avatar as a one-woman populist party, to establish a particular template of popular urban festivity and spectacle that serves as a prime site of governance. Teaching Programmes at The CSSSC

M.Phil in Social Sciences

[Conducted by Centre for Studies in Social Sciences, Calcutta (CSSSC) and affiliated to Jadavpur University, Kolkata]

The Centre runs a two-year M.Phil programme in Social Sciences that enjoys formal affiliation with Jadavpur University, Kolkata. It is one of its kind in the country as it is a multidisciplinary programme that provides students with a selected introduction to key theories and debates across different disciplines in the social sciences. The objective is to equip young researchers with a general grasp of the main intellectual concerns of social science research and a strong grounding in interdisciplinary methods.

The M.Phil programme has two parts: one-year teaching-course (semesters I and II) and one-year research-work for the writing of dissertation (semesters III and IV). In the first year, students are required to study four courses (one compulsory and three optional) and sit for an M.Phil Qualifying Examination. Only after a candidate clears the Qualifying Examination is s/he allowed to pursue with dissertation. In the second year, students are required to make three presentations in the presence of faculty members, presenting their work-in-progress.

Report for period from April 2017 to March 2018

In the M.Phil in Social Sciences 2015-17 batch, 11 students (out of a batch of 18) submitted their dissertations in May 2017. All 11 students were awarded the M.Phil degree in December 2017.

In the M.Phil in Social Sciences 2016-18 batch, 22 students completed their course work and cleared the Qualifying Examination (along with 1 student from the 2015-17 batch). The students commenced their research work and made two presentations during this period.

18 students were admitted in the M.Phil 2017-19 batch, out of a total of 276 applicants. 2 students dropped over the course of the year, leaving a batch of 16 students.

The Doctoral Programme

Since its inception, the Centre for Studies in Social Sciences, Calcutta, has accepted scholars wishing to pursue their Ph.Ds with specific faculty advisors. Annual report of the Archives and projects coordinated by Abhijit Bhattacharya and colleagues

1. Ongoing research projects funded by external agencies:

The sixth round of award from Endangered Archives Programme, EAP921: titled 'Early-modern texts and modern legacies: Digitisation of Manuscripts, Books, Newspapers in southern West Bengal' has already documented complete collection of Nihar a regional newspaper of Contai, a collection of 180 manuscripts from the Sisir Bani Mandir Pathagar, Guptipara, Hooghly, An excellent collection of manuscripts and books from the private collection of Dr. Shyamal Bera before the technical team moved to Sadharan Brahmo Samaj to digitize Brahmo tracts and related publications of the samaj. The project is expected to be completed by December 2018.

Abhijit Bhattacharya is the Principal Investigator of the project along with Dr. Rajarshi Ghose and Ms. Jayeeta Majumder.

Hitesranjan Sanyal Memorial Archives (April 2017 – March 2018)

During April 2017 and March 2018 the archive mainly acquired copies of documents copied and catalogued as part of Endangered Archives Project.

Achievements of individual Archive staff during 2017 - 18:

Collaborative Archive dissemination activities with South Asia Material Project and the National Digital Library of India are taking momentum in line of expectation.

CSSSC Library

The Library continues to serve the scholastic community effectively as ever. Scarcity of fund could not restrain the Library to introduce new edge technology to meet the demands of the changing scenario of library services. The zeal to render better information service has made Centre's Library a leader in the field of social sciences. The thrust to serve efficiently has been strengthened through introduction of KOHA and putting the catalogue online. Centre's Library probably is the only Indian library that runs a self-implemented, real– time processing system as far as "circulation of books" is concerned.

Books

During the financial year 2017-2018, the Library has purchased 38 books and has received 583 titles as gift.

Periodicals and Newspapers

76 print journals and 5 online resource-bases are subscribed along with 14 leading newspapers of the country. On this note, the Library is thankful to ICSSR for making a consortium to facilitate resource sharing.

Membership

46 non-borrowing members are added to the existing client-base and 38 members were provided temporary reading facilities for 10 days to 3 months. The Library also provides information service to affiliated "international" scholars of the Centre.

Footfall

As per records, 2188 users have consulted the Library resources excluding the faculty and other staff members of the Centre.

Library at Jadunath Bhavan

Since reopened on 10th August 2016, the library at Jadunath Bhavan has started serving the users from the very next day. JBMRC Library has a rich collection of books and reading materials mostly donated by eminent scholars from all over the world. The latest addition to its collection is the personal collection of a famous historian Gautam Bhadra.

JBMRC Library has more than 20,000 books and journals not only in English but in many other Indian languages such as Bengali, Oriya, Assamese, etc. The JBMRC Library has a good collection of printed materials published in French, Urdu and Tibetan, and many other famous languages.

Footfall

JBMRC Library not only serves the institutional scholars but non-institutional users also get access to the resources of this Library. A part from Centre's academic and non-academic staff, about 109 users have availed reading room facilities and accessed the resources.

Ongoing Activities for Modernization

The process of preparing an online public access catalogue (OPAC) for JBMRC Library has been initiated and creation of records for the electronic catalogue is in progress.

Jadunath Bhavan Museum And Resource Centre (JBMRC)

Work done towards the setting up of the Museum and the Resource Centre between April 2017-March 2018

During this period, several steps have been taken to make the Jadunath Bhavan Museum and Resource Centre fully functional.

- 1. After the setting up of the auditorium at the building, the JBMRC has organised a large number of public lectures, seminars, workshops, cultural events and inaugural programmes in this hall during this period. This hall is fully furnished and equipped with electrical amenities such as microphones and speakers, auditorium chairs, desks, lectern, blinds and background screen.
- 2. The library at the JBMRC has become fully functional during this period. At present, the staff members are engaged in the daily functioning of the library as well as updating the digital catalogue of all the library resources. The library at JBMRC has full collection of books, journal and newspapers in Bangla and other eastern Indian languages, and the books collections donated by different scholars.
- 3. During this period the second office of the Hiteshranjan Sanyal Memorial Archive became functional at the JBMRC. All the original storable materials of the Archive in the form of albums, negatives, transparencies and microfilms were shifted to the building. Two storage rooms at the building were turned into 24X7 air-conditioned and dehumidified spaces for the purpose of safekeeping of this material. Storage facilities for these two rooms was specially ordered and installed. Apart from this, the full furnishing at the JBMRC Archive has been completed during this period. The process of furnishing involved installation of new office furniture and reader tables, and installation of computers, scanners, printers and internet connections for the Archive staff. The JBMRC Archive has formally reopened on 22 July 2017. At present, the staff members are engaged in the daily functioning of the Archive as well as updating and cataloguing of all Archive resources.

- 3. Office spaces in the building have also been made ready for the institution's academic and administrative staff. The process of purchasing office furniture and computers for regular use in the rooms to be used by administrative staff and faculty has been completed.
- 4. A special meeting room has also been furnished and equipped for the holding of special closed-door meetings and for hosting the CSSSC's own Board of Governors meetings.
- 5. A full air-conditioned display area and gallery, with sliding ceiling to floor panels, and an attached smaller audio-visual lecture room, has been designed on the first floor, and it has already hosted a couple of major archival exhibitions.
- 6. The JBMRC is now a fully furnished and functioning institutional premise, and the JBMRC Library and Archives are at present open on all weekdays.

Future plans for which the release of the next instalment of the grant is urgently needed

- 1. Running a series of lectures at the venue by invited eminent scholars, artists, archivists, curators and collectors titled the JBMRC Lecture series.
- 2 Developing a set of curated circulating displays in the first floor rooms, dedicated to the different scholars whose personal collections of books and photographs have been donated to the CSSSC. These scholar book collections form a rare and special resource of the CSSSC and need to be brought to public attention. Some of these collections have been received along with old writing desks and bookshelves of the family. In keeping with ambience of these rooms, the plan is to have some old-style furniture

designed for these rooms and have wall panels on the life and career of scholars whose collections are held here.

- 4. Hosting temporary exhibitions out of the material in the visual archives of the CSSSC in the large gallery, and inviting artists and curators to use this space to mount other kinds of archival displays here.
- 5. Working on a series of archival publications by scholars on the material held at JBMRC, and designing museum merchandise like card and postcard sets, bookmarks, calendars and diaries, for sale at the venue.

Affiliation Involving Other Academic Institutions

Affiliation to Scholars from other Academic Institutions

The Centre extends affiliation to a number of visiting scholars who apply for such affiliation. This involves no financial responsibility on the part of the Centre. Affiliation for most American students is routed through the American Institute for Indian Studies. Affiliated scholars are requested to pay Rs.10000 for a period of six months and Rs.20,000 for a period exceeding six months.

The affiliation is mutually beneficial. Most of the scholars are also assigned a specific member of the faculty who takes the responsibility of extending academic cooperation. The scholar is encouraged to present his research before the faculty. Additionally some of them work closely on collaborative research with the Centre's faculty. In some cases, they also offer valuable teaching assistance to the academic programmes at the Centre.

COGSASH Annual Report 2017-18

The Centre for Studies in Social Sciences formally adopted a policy on gender sensitization against sexual harassment in September 2010, and set up a Committee on Gender Sensitization against Sexual harassment (COGSASH) in October 2010. COGSASH has eleven members (two students, two project staff, three administrative staff, three faculty representatives, and one member from outside the Centre). The Committee has the mandate of undertaking gender sensitization activities and creating greater awareness about sexual harassment; it also deals with any complaints of sexual harassment that are reported. The current COGSASH (whose tenure runs from October 2016 to October 2018) organized a gender sensitization event on the topic What needs to be done: Sexual Harassment at the Workplace" for all employees and students of the Centre on 16 January, 2018, at the Patuli campus. The broad focus of the event was to take stock of existing institutional mechanisms for gender sensitization and situate their working in the context of a larger feminist theory and politics. The event started with a panel discussion by Prof. Ruchira Goswami (NUJS) and Prof. Ritu Sen Chowdhury, West Bengal State University Barasat, and was followed by an open discussion. Following the panel discussion, there was a round of semi-formal discussion between COGSASH members and other members of the faculty (who had closely been associated with COGSASH's functioning from the beginning) and the students, regarding suggested changes and reconsiderations to some of the clauses in the existing COGSASH policy. The suggestions that came up in the discussion, as well as some other modifications deemed necessary by some of the COGSASH members, are being pursued and, hopefully, will see constructive progress before the term of the current committee ends in October 2018.
